Michigan High School X-C Skiing Championships Release and Indemnity Agreement, Assumption of Risk Friday February 17 & Saturday February 18, 2007

In Consideration of myself or my child being permitted to participate in any way in the Michigan High School X-C Skiing Championships (Saturday and Sunday , Feb 17 & 18, 2007), I represent that I do, on behalf of myself OR my child:

1. acknowledge, agree and represent I fully understand the nature of Nordic skiing and the Michigan High School X-C Skiing Championships and that I or my child are qualified, in good health, and in proper physical condition to participate in such activity.
2. fully understand that (a) the Michigan High School X-C Skiing Championships involves risk and dangers of serious bodily injury (b) these risks and dangers may be caused by my own (or my child's) actions or inactions, or the actions or inactions of others participating in the Noque, and/or the condition of which the Noque takes place.
